- Applications for the judging lists or progression to another list can only be made via anyone of the above Breed Clubs.
  - The applicant should send copies of the fully completed questionnaire and appropriate certificates to one of the Breed Club secretary's for scrutiny. These can be scanned and sent by email.
  - Applications will be forwarded to the remaining club secretaries for consideration at their next available meeting.
  - At the working party meeting, voting on the application will take place and those achieving majority approval will be invited to join the relevant list.
  - Applications will only be accepted on the correct form and applications that do not meet the criteria will be returned.
  - Each page of the application form must be signed and dated by the applicant.
  - Judges must have been approved for appropriate lists before accepting any appointment.

## **A3 LIST**

For persons whom the clubs would support and whom have previously been approved by The Kennel Club to award CC's in the breed having completed their first appointment.

## **A3 LIST**

This list contains persons who, as yet, have not been approved by The Kennel Club and who are considered by the clubs to have sufficient knowledge of the Dobermann and experience of judging the breed to be recommended and supported to award CC's. These persons will be assessed by The KC when judging their first appointment.

## **A3 LIST – BREED SPECIALIST**

1. To have a minimum of 7 (seven) years judging experience in any breed.
2. To have judged Dobermanns for a period of 5 (five) years.
3. To have attended at least 1 (one) Dobermann Breed Seminar/Breed Appreciation Day (BAD) and to have passed the multiple choice question paper on the breed standard run in accordance with the relevant Kennel Club Code of Best Practice.
4. To have attended and passed a Dobermann Judging Competence Assessment run in accordance with the relevant Kennel Club Code of best Practice.
5. To have attended a seminar given by a Kennel Club Accredited Trainer and passed the relevant examination on Kennel Club Regulations and Judging Procedures.
6. To have attended a seminar given by a Kennel Club Accredited Trainer on Conformation & Movement.
7. To have attended a Points of the Dog Assessment conducted by a Kennel Club Accredited Trainer and passed the assessment.
8. To have judged a minimum of 40 (forty) classes of Dobermanns at Open or Championship Shows without CC's.
9. To have judged the breed at a minimum of 10 (ten) Open or Championship Shows without CC's with an adequate geographical spread.
10. To have judged a minimum of 120 (one hundred and twenty) dogs Hands On.
11. To have judged at least 1 (one) Dobermann Breed Club Open Show or Championship Show without CC's.
12. To have awarded CC's in at least one other breed.
13. To have bred and/or owned a minimum of 3 (three) dogs when they obtained their 1st entry in The Kennel Club Stud Book (Save in exceptional circumstances).
14. To have stewarded for a minimum of 6 (six) days.\*
